In short law is very competitive and career ready students in law even at that early stage. I highly recommend you look into degrees where you can start a protected title role straight after ie. like pharmacy, nursing, paramedic. If you continue to do law and don't end up doing anything like it its counterproductive and you end up doing more for a regular bachelors degree with like high competition to secure the relevant roles such as trainee solicitor.
