In English, when a word ends in ‘y’ and is preceded by a consonant, to make an adverb we replace the ‘y’ with ‘i’ and add ‘ly’. For example, the adjective ‘legal’ becomes the adverb ‘legally’. You would say, “She was acting legally when she signed the document,” meaning she followed the law. Understanding Basic Spelling Rules English has a handful of rules that tell us how to form words correctly. You might already know the “magic” rule: if a word ends in ‘y’, and there’s a consonant before the ‘y’, change the ‘y’ to ‘i’ and add ‘es’ or ‘ed’ or ‘ly’. Isn’t that interesting? The word ‘legal’ ends in ‘l’ which is a consonant, and just before that is an ‘a’ which is a vowel. Since it doesn’t end in ‘y’, we don’t change it; we simply add ‘-ly’. The correct spelling is ‘legally’. Why is ‘Legaly’ Incorrect? Have you ever typed something fast, maybe in a text or a note, and missed out a letter? It’s pretty common, right? ‘Legaly’ is a bit like that mistake. When we’re learning the rules, sometimes it’s easy to forget things like repeating the ‘l’ before adding ‘ly’. But remember, practice makes perfect! Examples in Sentences Using words correctly helps cement them in our minds. Here’s how you can use ‘legally’: Is she legally allowed to drive this car? He needs to handle these documents legally. They were legally married in a lovely ceremony. What About Other Words? You might wonder if this rule works the same for all words ending with an ‘l’. The answer is yes! Think about ‘final’. It becomes ‘finally’. What about ‘usual’? It becomes ‘usually’. See the pattern? Understanding these patterns helps you navigate English better. Isn’t it a bit like having a map when you’re visiting a new city? It gives you confidence to wander and explore! Why Spelling Matters Why do we even bother with spelling things correctly? Well, think of each correctly spelled word as a bridge. It helps people understand us better and connect with our ideas. When you spell words correctly, it’s easier for others to read your writing.
